# draft MINUTES

Special Meeting September 5, 2019

The meeting was called to order at 6:00 p.m. in Conference Room 5, located in the City of Ukiah Civic Center Annex, 411 West Clay, Ukiah, CA by Chair Janet Pauli.

#### **Public Expression**

Chair Pauli explained that anything not currently on the agenda may be discussed at this time, however no action could be taken. She further advised that comments would be welcome throughout the meeting.

Commissioner Talso suggested that the Mendocino County Historical Society Journal would be a good publication for information on the PVP as it goes out to 600 people.

#### Minutes

On a motion by Commissioner Talso, seconded by Orozco, the minutes of the meeting of August 8 were unanimously approved

#### **Consent Calendar**

On a motion by Vice-Chair Reardan, seconded by Talso, the consent calendar items for August 2019 were unanimously approved.

#### **Commissioner Reports**

- a. Report from the Upper Russian River Stewardship Alliance regarding frost water use—No report.
- b. <u>Eel/Russian River Commission meeting update</u>—Commissioner Carre Brown reported that PG&E came to the meeting and gave an update on the PVP and possible new Pikeminnow eradication efforts. A presentation was given by Chair Pauli and Hank Seeman from Humboldt County on the NOI Partners Group.
- c. <u>North Coast Quagga/Zebra Mussel Prevention Consortium update</u>—The mussel smelling dogs are still being worked at the lake and being paid for by Sonoma Water.
- d. Update regarding actions and discussion of the state water bond issues—No report.
- e. <u>Report on the Upper Russian River Water Agency JPA</u>— Salomone reported that they are still looking for a consultant to help restructure the JPA document to allow for increased autonomy for each district. They are also working on water supply issues including the possibility for RRFCD to supply water to RVCWD. RRFCD has submitted a pre-application to LAFCO for options including annexation to Redwood Valley to be able to serve water to that area. They are still looking at whether this is a valid option or not.
- f. <u>Report on Upper Russian River Water Manager's meeting</u>—The next meeting will be on September 18, from 3 to 5 pm at the Cloverdale Fire house.
- g. <u>Discussion of ground water rights & Sustainable Groundwater Mgmt Act (SGMA)</u>—The next meeting is on Thursday, September 12 at 1:30 pm at the BOS chambers. They are hoping to have the BOS look over the Plan and possibly approve it at the October meeting. The TAC has been going over everything the consultant has done. There are some issues with monitoring wells that need be cross sectioned from each other, as the Department of Water Resources did not approve three of the proposed well sites. Other potential sites in proximity of these three have been identified.
- h. <u>City of Ukiah purple pipe recycled water program</u>—Commissioner Jim Brown reported that Phase 4, which would take the pipe all the way up to the golf course, is on hold for several years due to lack of funding.
- i. <u>Russian River Confluence project update</u>—No report. The Commissioners approved taking this item off of the agenda.
- j. <u>CalCannabis regulation and related issues</u>—Commissioner Carre Brown reported that there are working groups going over the regulations at the State level and bringing forth recommendations to the BOS. A bill is being proposed at the State level to allow grows to be counted under the Williamson Act. There is pressure on the County to allow Hemp grows.

# Potter Valley Project

a. Status report and discussion of the NOI Partners efforts to license the Potter Valley Project—Chair Pauli reported that the Round Valley Tribes have signed the Planning Agreement but wanted to discuss the issue of contribution. They have spent \$300,000 in consultant fees already by hiring McBain and Associates for Huffman's Ad Hoc subcommittee and preparing other studies that can be used for the Feasibility Study moving forward. They are going to fund raise, apply to Foundations and ask for Federal funds under several different options to obtain the funds for the NOI Partners group. The NOI Partners have determined that the Round Valley Tribes can be nominated to join the group. Additionally, the County of Lake has approved a resolution confirming their support, to participate in the Planning Agreement and to pursue funding to participate in the Group. The IWPC representative will nominate Lake County to join the NOI Partners group but there must be a consensus of all the parties in the group to have them be a partner. The Wiyot Tribe also has expressed interest but not gone further so have not been nominated by any of the partners as yet. There needs to be a cutoff number of Partners and they are looking at an 8 member limit. The Potter Valley and Dry Creek Tribes may also be interested.

The NOI Partners steering committee for hiring a consultant to prepare a FS for FERC by April 2020 are planning on finalizing their scoring of the applicants by the end of the week. They hope to make a decision by Sept. 19 and signing a contract by Sept. 30. There is a long laundry list of other things to get done including analyzing the studies that have already been completed, looking at potential changes in projects, and what new studies need to be done. Tom Johnson and Pauli are working on these issues.

- b. <u>Update on current Lake Pillsbury releases to the Eel & Russian rivers</u>—Chair Pauli reported that PG&E have cleared all the debris and sediment in the fish ladder and hotel at Cape Horn dam from last winter's floods. On June 10<sup>th</sup> PG&E had a turbine fail and though they have repaired it, they have asked for a variance to increase the flows through PVP for two days to check the repairs.
- c. <u>Sam Sandoval Study</u>—No report.

#### **Update on the IWPC Communication Program**

a. <u>Website</u>—The Mendocino Farm Bureau had hired Jendi Coursey to do publicity for them and now to work on a new website, 'OurSharedWater', that would be linked back to IWPC and would serve as a one stop shop for information on the PVP process. This will be brought back at the next meeting to determine which way the Commission wants to go.
