Regular Meeting April 11, 2019

The meeting was called to order at 6:00 p.m. in Conference Room 5, located in the City of Ukiah Civic Center Annex, 411 West Clay, Ukiah, CA by Chair Janet Pauli.

Public Expression

Chair Pauli explained that anything not currently on the agenda may be discussed at this time, however no action could be taken. She further advised that comments would be welcome throughout the meeting.

Minutes

On a motion by Commissioner Brown, seconded by Talso, the minutes of the regular meeting of March 14, 2019 were unanimously approved. On a motion by Brown, seconded by Reardan, the minutes of the special meeting of March 21, 2019 were unanimously approved.

Consent Calendar

On a motion by Commissioner Brown, seconded by Reardan, the consent calendar items for March 2019 were unanimously approved

Commissioner Reports

- a. Report from the Upper Russian River Stewardship Alliance regarding frost water use—Riparian water rights reports are due by July 1st.
- b. <u>Eel/Russian River Commission meeting update</u>—Brown reported on the March 29th meeting. There was an update from PG&E on fish counts, the fish ladder and water levels. Other speakers included Cal Trout, Patrick Higgins and Janet Pauli. The Wiyot tribe read a resolution which stated their position to remove both Scott and Van Arsdale dams. The representative from Round Valley Tribe stated that they had passed a resolution that no further diversions from the Eel River should be made. Pauli talked about coalitions, working together, Huffman's Ad Hoc committees and all the concerns IWPC has regarding the project. The next meeting is scheduled for May 24 in Lake County at the Board of Supervisors chambers. The rest of 2019 meetings are calendared for August 23 in Mendocino County and November 22 in Sonoma County.
- c. North Coast Quagga/Zebra Mussel Prevention Consortium update—No report.
- d. <u>Update regarding actions and discussion of the state water bond issues</u>—No report.
- e. Report on the Upper Russian River Water Agency JPA—No report.
- f. Report on Upper Russian River Water Manager's meeting—White reported that the main topic of the meeting was on the implementation of FIRO at Lake Mendocino this year. It was not the best year to reveal its true usefulness, due to the amount of rain we have had this winter, but it will be used again next year which may provide a better evaluation. The second issue discussed at length was the PVP.
- g. <u>Discussion of ground water rights & Sustainable Groundwater Mgmt Act (SGMA)</u>--The next meeting will be in June.
- h. <u>City of Ukiah purple pipe recycled water program</u>—White reported that they are installing meters and pumps at this time and are ramping up for Phase 4. He stated that users of the recycled water can report the water use under the Conservation section to help maximize their appropriate water use right.
- i. <u>Discussion of SB88 (measurement requirements for water diverters)</u>—Jones reported that grant funds are available to help purchase compliant meters. If you purchased a meter after 2016 you can qualify to get a rebate on the cost of the meter.
- j. Russian River Confluence project update—No report.
- k. <u>CalCannabis regulation and related issues</u>—Commissioner Brown reported that Mendocino County has placed a moratorium on commercial hemp production and sales until February 2020 to give California time to set up their rules and regulations for this use before the County attempts to draft its regulations.

Chair Pauli reported that she and Jones have talked with the Sonoma County Farm Bureau, Russian River property owners' group, Business and Ag consortium in Sonoma County, and Lake Pillsbury Alliance. They also visited with Congressman John Garamendi's field representative to give him a heads up on what is at stake for Lake County regarding the PVP. Jones handed out an informational paper that she has put together for these meetings.

Potter Valley Project

- a. <u>Status report and discussion of the FERC Orphan Project process for the PVP</u>—Chair Pauli reported that Congressman Huffman has invited a FERC representative to be available by phone at next month's meeting so the participants will be able to ask questions regarding the Orphan project process.
- b. <u>Update on current Lake Pillsbury releases to the Eel & Russian rivers</u>—Pauli reported that the lake is full and spilling over the spillway. There has been 517,000 AF of cumulative inflow to the Lake Pillsbury. Water flow through the PVP is only at 45 CFS but Lake Mendocino storage is very high due to the rains. Fish returns: steelhead count 288 for the season, 95 Chinook.
- c. <u>Sam Sandoval Study</u>— Pauli is having a meeting with Sandoval next week to get an update on the modeling and study. The Commissioners are welcome to attend on Tuesday, April 16 at 1pm in the Ag Commissioners office.
